### **2014 IDAHO COURSE DESCRIPTIONS**

### WATER DISTRIBUTION CERTIFICATION EXAM REVIEW

This two-day course prepares students for *all levels* of Water Distribution Certification exams. Small class sizes allow the course to be customized according to the student's certification levels. The curriculum begins with an extensive review of the drinking water regulations, then covers topics such as

math and chemistry; disinfection rules and procedures; basic well construction and development; and water utility management, operations and maintenance principles. If it's on the Association of Boards of Certification's "Need to Know" criteria for Water Distribution, it's covered during this class\*. Each student also receives their own copy of Backflow Management Inc.'s Water Distribution Certification manual, a \$50 value.

### WATER TREATMENT CERTIFICATION EXAM REVIEW

This two-day course prepares students for *all levels* the Water Treatment Operator Certification Exam. Small class sizes allow the course to be customized according to the student's certification levels. The review topics include math for Treatment Plant Operators, water sources and treatment coagulation and flocculation, corrosion control, and overview of plant operation and treatment, softening systems and laboratory procedures. The curriculum aligns with the Association of Boards of Certification's "Need to Know" criteria for Water Treatment\*. Each student also receives their own copy of Backflow Management Inc.'s Water Treatment Plant Operator manual, a \$50 value.

### CHLORINATION WORKSHOP

This one-day class provides an in-depth discussion on the different types of chlorine, methods of chlorination, proper application, and how to de-chlorinate when necessary. Chlorine's role in the formation of disinfection by-products will also be covered. *Tuition fee for this workshop includes lunch!*
