### Course Descriptions

**Asbestos Safety for Water Operators:** A half-day course that looks at the importance of the safe handling of asbestos cement pipe in the distribution system. Also presented are proper disposal, equipment, history and health issues.

**Basic to Advanced Math for Water Operators:** A half-day course that will begin with a basic math review and move into formulas commonly used in the industry with an emphasis on preparing attendees to successfully take certification exams.

**Injector Pumps for Water Treatment:** A five-hour course that looks at the application and use relative to various types of treatments for both water and wastewater operators. Maintenance and troubleshooting will be presented.

**Managing and Owning a Public Water System:** A one-day course that will look at regulations, liability and rate setting for a public water system with an emphasis on running a business.

**Water Distribution Exam Review:** This two-day course provides an exam review to prepare attendees to take water distribution certification exams.

**Water Distribution One-Day Exam Review:** This one-day course provides an exam review to prepare attendees to take Level 3 & 4 water distribution certification exams.

**Water Treatment Operator Exam Review:** This two-day course provides an exam review to prepare attendees to take water treatment or basic treatment operator certification exams.

**What Your Chlorine Residual is Telling You:** This half-day course will assist operators in understanding the benefits and importance of chlorine as a disinfectant and why it is important to maintain a residual.
